



Allocating Agency Agreement for Transportation

Subject to the approval of TransGas, _____ (the "CSO") requests that _____ (the "Allocating Agent") be appointed to take responsibility on behalf of the CSO for compliance as set out in the TransGas Comprehensive Tariff respecting the daily and monthly allocation requirements. The Allocating Agent will have all the power and authority required to perform all allocating functions necessary in relation to the Agent's authority for those Points of Receipt set out below on behalf of CSO. Further, CSO agrees that TransGas has full authority to deal with the Allocating Agent with respect to all allocation matters relating to the Agent's authority as set out below, as if dealing directly with the CSO.

CSO Terms and Conditions

More specifically, the CSO hereby authorizes the Allocating Agent to exercise those rights under the Common Stream Operations Service Specification and the Common Stream Operations Service Specification Terms and Conditions relating to the allocation of daily and monthly energies for those Points of Receipt outlined below:

** Note that, if a CSO wishes to assign all of its Points of Receipt to an Allocating Agent, instead of listing all the Points of Receipts in the tables above, the CSO can specify "All Points of Receipt."*

Notwithstanding this agency appointment, nothing in this authorization shall diminish or relieve the CSO of the responsibility to ensure compliance with contractual obligations to TransGas pursuant to the Common Stream Operations Service Specification and the Common Stream Operations Service Specification Terms and Conditions. CSO hereby agrees to indemnify and save harmless TransGas from any losses, demands, claims, costs or expenses that it may incur or that may arise due to TransGas' reliance upon the Allocating Agent's authority.

The parties further agree that the Allocating Agent accepts full responsibility to comply with requests from TransGas in relation to those matters within the scope of the Common Stream Operations Service Specification and the Common Stream Operations Service Specification Terms and Conditions.

This appointment of Allocating Agent shall be effective _____, and shall remain in effect until the earlier of:

- 1) written notice of termination of the agency appointment is received by TransGas from CSO;
- 2) written notice is provided by TransGas to CSO terminating the Agent's appointment due to default; or

This Allocating Agency Agreement shall be governed by and construed in accordance with the laws of the Province of Saskatchewan. Nothing herein contained shall release CSO from any of its obligations, agreements, covenants, representations or warranties contained in the Common Stream Operations Service Specification and the Common Stream Operations Service Specification Terms and Conditions.

In the event the corporate seal of CSO is not affixed to this agreement, I/we the signatories on behalf of the CSO hereby confirm and warrant in favour of TransGas that I/we have authority to execute this agreement on behalf of CSO.
