However, the Assignor remains ultimately obligated for the observance and performance of the Terms and Conditions of the Storage Contract, with respect to the assigned Contracted Capacity and/or Contracted Rate of Withdrawal. Further, the Assignor shall remain obligated to post any and all security requirements pursuant to the TransGas Security Policy.
