The Assignor understands that, prior to any requested assignment becoming effective, this request is subject to review and approval by TransGas, in accordance with TransGas' policies and procedures relating to Assignment requests. In the event that TransGas approves the within request, the Assignor agrees to be bound by the terms and conditions set out in Appendix A, attached to and forming part of this request.

The Assignor further agrees that by virtue of this request for an assignment, the Assignor is granting authorization to TransGas that, in the event the within request is approved by TransGas, TransGas has the authority to make any necessary amendments to the Assignor's Storage Schedule of Service in order to achieve the requested assignment. The Assignor agrees to be bound by the terms and conditions of any such amendments.

The Assignor further agrees this request is an Assignment request only and if requested accordingly by the Assignee and approved by TransGas, the Assignee will hold the same rights to the assigned Contracted Capacity and/or Contracted Rate of Withdrawal, which were held by the Assignor under the Storage Contract at the effective date of the Assignment.

I hereby warrant in favor of TransGas that I have authority to sign this Assignment Request and authorize this Assignment on behalf of the Assignor.

- This Assignor and the Assignee shall be responsible to ensure that, upon approval of this Assignment Request, the required adjustments are made to the Customer's (Assignor's) Inventory in order to accommodate the assigned Contracted Capacity and/or Contracted Rate of Withdrawal. Failure to make any necessary adjustments may result in the imposition of overholding charges.
- The Assignor shall be responsible for rectifying any outstanding obligations in existence at the effective date of the within Assignment, with respect to the assigned Contracted Capacity and/or Contracted Rate of Withdrawal.
- The Assignor further agrees to execute such further assurances and do all such further acts as may be reasonably necessary for the purpose of effecting the Assignment.
- In the event a temporary Assignment is selected, and subject to the foregoing, TransGas will first look for performance of the obligations of the Terms and Conditions of the Storage Contract from the Assignee. However, the Assignor remains ultimately obligated for the observance and performance of the Terms and Conditions of the Storage Contract, with respect to the assigned Contracted Capacity and/or Contracted Rate of Withdrawal. Further, the Assignor shall remain obligated to post any and all security requirements pursuant to the TransGas Security Policy.
