The Assignee understands that, prior to any requested Contract Demand Assignment becoming effective, this request is subject to review and approval by TransGas, in accordance with TransGas' policies and procedures relating to Contract Demand Assignment requests.

In the event that TransGas approves the within request, the Assignee further agrees to be bound by the terms and conditions set out in Appendix A, attached to and forming part of this request.

The Assignee further agrees that by virtue of this request for a Contract Demand Assignment, the Assignee is granting authorization to TransGas that, in the event the within request is approved by TransGas, TransGas has the authority to make any necessary amendments to the Assignee's Transportation Schedule of Service, or issue a new Transportation Schedule of Service, if required, in order to achieve the requested Contract Demand Assignment. The Assignee agrees to be bound by the terms and conditions of any such Transportation Schedule of Service or amendment thereof.

The Assignee further agrees this request is a Contract Demand Assignment request only and if requested accordingly by the Assignor and approved by TransGas, the Assignee will hold the same Transportation rights, which were held by the Assignor at the effective date of the Contract Demand Assignment.

I hereby warrant in favor of TransGas that I have authority to sign this Transportation Contract Demand Assignment Request and authorize this Contract Demand Assignment on behalf of the Assignee.

Transfers: Requests for transfers of Transportation Contract Demand, to another Point of Receipt or Point of Delivery, must be requested separately by the current holder of the Transportation Schedule of Service. In the event, the current Transportation Schedule of Service is held by virtue of a temporary Contract Demand Assignment, any request for a transfer of Transportation Contract Demand must be requested by both the Assignee and the Assignor.

Assignments: An Assignee cannot request an assignment of Contract Demand held by virtue of a temporary Contract Demand Assignment.

Appendix A

- The Assignee agrees to be bound by the terms and conditions applicable to the assigned Contract Demand, in accordance with TransGas' Transportation Tariff of Terms and Conditions, published in accordance with the provisions of The SaskEnergy Act, 1992, for the duration of the Contract Demand Assignment, and further, the Assignee agrees that it shall execute such further assurances and do all such further acts as may be reasonably necessary for the purpose of effecting the Transportation Demand Assignment.
- In the event of a permanent Contract Demand Assignment, the Assignor shall assign all rights and obligations including any rebates of outstanding Customer Contributions, which may accrue pursuant to the TransGas Standard Investment Policy, for the capacity assigned. For temporary Assignments, the Assignor shall retain all rights to any rebates for the temporary assignment period.
- In the event a temporary Contract Demand Assignment is selected, and subject to the foregoing, TransGas will first look for performance of the obligations of the Terms and Conditions of the Transportation Schedule of Service from the Assignee. However, the Assignor remains ultimately obligated for the observance and performance of the Terms and Conditions of the Transportation Schedule of Service, with respect to the assigned Transportation Demand. Further, the Assignor shall remain obligated to post any and all security requirements pursuant to the TransGas Security Policy.
