## Offer Sheet SUMMER USE STORAGE SERVICE

This Binding Open Season is being conducted pursuant to the terms and conditions contained within the TransGas Comprehensive Tariff and the terms and conditions set out herein.

**ELIGIBILITY:** All TransGas Customers  
**EFFECTIVE DATE:** July 1, 2020 to April 30, 2021  
**SERVICE:** Summer Use Storage

- 1.7 PJ of storage capacity (1 700 000 GJs);
- Term of service = July 1, 2020 to April 30, 2021
- S-49 rate Summer Use Interruptible;
- This service does not have any injection rights associated with it; injection would be by injection rights acquired as biddable injection service or excess injection service;
- Transfers into this storage service will be allowed throughout the entire service;
- Withdrawals or transfers from this storage service will not be allowed during the period November 1, 2020 to March 31, 2021
- Inventory must be removed from this storage service storage by the end of the term of service (April 30, 2021)

This summer use storage service will be allocated to all parties expressing an interest on a pro rata share basis (each request will be prorated by the ratio of the capacity available divided by the total requested capacity).

Customer responding to this Open Season will not be assigned a queue position. Binding Open Season requests will be considered as official service requests. This offer is conditional only upon TransGas satisfying the storage service quantity identified below.

TransGas intends to contact interested parties regarding the amount of service allocated to their service request immediately after the close of the Open Season. TransGas will enter a Request for Service (RFS) online confirming this service request, which will then be approved shortly after the RFS is submitted.
