NIT to TEP Firm and Interruptible Restriction for TransGas System
UPDATE

TransGas is providing you with notice of upcoming outages on interconnecting pipelines. The restrictions will result in a significant impact to TransGas and our ability to meet NIT to TEP firm contracts. TransGas is working closely with the associated pipelines regarding timing and volumes impacted. During these planned outages, TransGas will attempt to coordinate system outages to avoid future outages in the area.

There has been an update since the last notice sent on October 7, 2020. Changes below are noted in red.

RESTRICTION:

Gas Days September 29, 2020 – October 10, 2020 TC Energy Restrictions

TC Energy will be having restrictions which may cause potential firm impacts. All NIT to TEP customers may be restricted as per the table below from September 29th at 09:00 AM to October 11th at 09:00 AM. The restriction will be evaluated daily and all efforts will be made to reduce customer impact.

Dates	All NIT to TEP customers will be curtailed to:
September 29 th 9:00 AM to October 1 st 9:00 AM	85%
October 1 st 9:00 AM to October 2 nd 9:00 AM	90%
October 2 nd 9:00 AM to October 6 th 9:00 AM	88%
October 6 th 9:00 AM to October 7 th 9:00 AM	90%
October 7 th 9:00 AM to October 8 th 9:00 AM	83%
October 8 th 9:00 AM to October 9 th 9:00 AM	88%
October 9th 9:00 AM to October 11th 9:00 AM	90%

On October 11th at 9:00, the NIT to TEP restriction will be over and customers can flow 100% of their firm contracted flow.

CANCELLED OUTAGE: October 15, 2020 – October 20, 2020 Foothills Pipeline Maintenance (Shaunavon to Monchy)

TransGas no longer expects an impact to NIT to TEP during these dates.

RESTRICTION:

Gas Days October 29, 2020 – November 5, 2020 TC Energy Restrictions

TC Energy will be performing a tool run near the Cold Lake border point. As per early restriction estimates, all NIT to TEP customers may be restricted as per the table below from October 29th at 09:00 AM to November 6th at 09:00 AM.

Dates	All NIT to TEP customers will be curtailed to:
October 29 th 9:00 AM to November 1 st 9:00 AM	99%
November 1 st 9:00 AM to November 6 th 9:00 AM	95%

Please note the percentages given, is based on current estimates and the potential exists for them to change (higher or lower).
